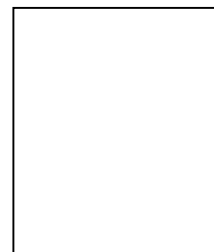

## WALK – IN INTERVIEW OF CONTRACTUAL TEACHERS FOR SESSION 2024-25

Instructor, Odia Teacher, Special Educator, Nurse etc.

### General Instructions:

- (i) Interested eligible candidates are required to download the Application Form from school website.
- (ii) The duly filled in application form is to be submitted at the school office on the day of interview.
- (iii) If any candidate wants to apply for more than one post, he/she should submit separate form for each post.
- (iv) Each form should be duly filled in all respects without any mistake.
- (v) No documents should be attached with the application form.
- (vi) Candidates will have to report to the school on time with all original documents in support of their qualification and experience along with a set of self-attested copies of all the requisite documents.
- (vii) Application form is available on the school website “**dharamgarh.kvs.ac.in**” (At the end of this advertisement).
- (viii) Candidate having CTET pass certificate (as applicable to that post) shall be given preference.
- (ix) Remuneration will be as per KVS norms from time to time.
- (x) Eligible candidates may attend the interview along with all the original documents. Ineligible candidates or those candidates who do not produce the required certificates to prove their eligibility shall not be allowed to attend interview.
- (xi) According to the vacancy, the selected candidates will be called by telephonic information or by mail as and when required.
- (xii) No TA/DA is applicable for attending interview.
- (xiii) **All statements and information given in this application are true, complete and correct. In the event of any information or part of it being found false or incorrect before or after the exam./interview or after Part – Time contractual appointment, action can be taken against the candidate by the KVS/Vidyalaya and his/her candidature/appointment(contractual) shall automatically stand cancelled.**
- (xiv) All the conditions of eligibility regarding age and educational, professional / technical qualification etc. will be decided as on 31/03/2024.
- (xv) There will be no claim of reservation for SC/ST/OBC/Minority etc. and candidates will have no right to claim for regular appointment in KVS as this advertisement is only for this Vidyalaya temporary arrangement and on part–time contractual basis.
- (xvi) **Working knowledge of Computer Application and bilingual competency (English & Hindi language) is desirable.**
- (xvii) Interested eligible candidate are requested to download the application from school website
- (xviii) No TA/DA shall be paid for appearing in walk-in-interview.
- (xix) Appearing in interview does not confer the right to appointment on contractual basis.
- (xx) Part-time contractual engagement is subject to clear vacancy that exists or the vacancy which arises when a teacher proceeds on long leave.
- (xxi) Teachers engaged on contractual basis, would have no right to claim for appointment on a regular basis nor will they be a part of the cadre of teachers of Kendriya Vidyalaya.
- (xxii) The part-time contractual teachers will be engaged till the regular teacher joins or till the end of the academic session, whichever is earlier.
- (xxiii) Contrary to the above the services of a part time contractual teacher can be terminated any time if his/her performance is not up to the mark.

- (xxiv) Teachers engaged on contractual basis will not be entitled for vacation pay and during Autumn/Winter Break.
- (xxv) Teacher will not be entitled for pay, if remains absent on working day. In case of absence from duty, payment will be calculated on pro rata basis.
- (xxvi) The panel drawn on the basis of interview will be valid for one academic session (i.e. session 2024-25) only.
- (xxvii) Selected candidates will be informed over phone or by e-mail only. So please provide your valid phone-number & e-mail Id. In case a candidate does not respond within 3 days the next in the panel will be given chance and the candidature of the first candidate will stand forfeited.
- (xxviii) Teachers engaged on Part-Time Contractual basis have to attend works allotted by the principal. Works are generally regular classroom activity/copy checking/invigilation /evaluation/enriching curricular/co-curricular activities of children/ or any other works assigned by the principal as and when required for the school.
